History

October 1946	Tomosaburo Kawashima established Kawashima Iron Works Co., Ltd. with a capital of 1 million yen in Tokiwamachi, Takasaki City.
Jun 1973	A new factory was built and the company fully relocated to 571-6 Kamitoyooka-cho, Takasaki City (current address). At the same time, the capital was increased to 4 million yen.
January 1977	Jun Kawashima became President.
September 1984	A rubber division was newly established, and the production of industrial rubber products began.
May 1989	The company name was changed to Kawashima Kogyo Co., Ltd. (operating with two divisions: Iron Works and Rubber).
March 1991	Production of sponge rubber products and rubber rollers commenced.
January 1993	Capital was increased to 25 million yen.
April 1994	A molding factory was established and began operations under the Social Welfare Corporation seiran Gakuen.
October 2003	Selected for "One Company, One Technology."
March 2004	Commenced parts assembly processing by department. Obtained ISO 9001 certification
March 2007	Established and began operations at the Yawata Factory as an assembly division.
April 2008	Masayasu Kawashima was appointed President.
March 2012	Expanded production of adhesive components for metals and rubber"
December 2019	Established the Indian subsidiary, Kawashima Rubber Industries Private Limited, and began operations primarily for automotive rubber parts.
May 2021	Moved the Yawata Factory to 561-25 Kamitoyooka-cho, Takasaki City, and it began operating as the second factory.
October 2021	Celebrated the 75th anniversary since its founding, continuing to the present day.

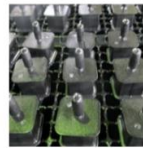
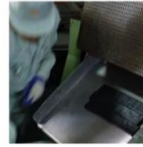
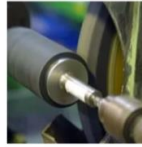
